

ADVERTISEMENT FOR BIDS

Subject to conditions prescribed by the University of California, Irvine, sealed bids for a Lump-Sum Contract are invited for the following project:

TRAFFIC SIGNALS ENGINEERING SERVICE ROAD & BISON AVENUE
Project No. 5112244 / Contract No. 999563

Estimated Construction Cost: \$1,150,000

License Class Required: A, General Engineering and C10, Electrical

Project Duration: Ninety (90) Calendar Days

General Description of Work:

The project will upgrade the two intersections of Engineering Service Road and East Peltason Drive, and Health Sciences Road and Bison Avenue, including:

1. Installation of new traffic signals and pedestrian signals, safety lighting improvements, sidewalks, and crosswalks at both intersections.
2. Widening of the south-bound Engineering Service Road approach toward East Peltason Drive from one shared left-turn and right-turn lane to one separate left-turn lane and one separate right-turn lane.

Assignment of Materials or Equipment Agreement: The University tendered to Gexpro ("Supplier") a Purchase Agreement for the fabrication of Traffic Signal Poles. A copy of the Purchase Agreement is issued as EXHIBIT "A" to the Assignment of Materials or Equipment Agreement with the bid documents. As part of its contract with the University, the successful Contractor shall assume assignment of said Purchase Agreement and shall assume all responsibility for receiving, handling, storage, transportation to job site, inspection, rigging, connecting, guarantees, bonding, and all other factors involved in producing a complete job. This assignment shall be made via this Assignment of Materials or Equipment Agreement between University and Contractor, executed at the award of contract.

Procedures: Bidders may obtain bid documents beginning on Tuesday, December 4, 2018 at 2:00 PM at CRISP Imaging, 3180 Pullman Street, Costa Mesa, CA 92626, (714) 545-0112.

Bidder Qualifications: The successful Contractor will be required to have the following California contractor's license (s): active at the time of submission of the Bid:

A, GENERAL ENGINEERING AND C10, ELECTRICAL

Bidders will be required to submit a completed Statement of Bidder's Qualifications at the time of bid. Bidders that do not submit a completed Statement of Bidder's Qualifications or do not meet the University's requirements for relevant project experience, financial ability to complete the project, safety record and professional conduct will not be eligible for award.

Mandatory Pre-Bid Conference: The Pre-Bid Conference and Job Walk will be conducted on **Friday, December 14, 2018 at 9:00 am** at UCI Design & Construction Services, Wright Conference Room, 101 Academy, Suite 200, Irvine, CA 92697. Contractors arriving after **9:00 am** will not be eligible to participate in the bid process as a General Contractor. Only bidders who participate in both the pre-bid conference and the job walk in their entirety will be allowed to bid on the Project as General Contractors.

Bid Submittal Requirements: Sealed bids will be received only at: UCI Design & Construction Services, 101 Academy, Suite 200, Irvine, CA 92697 on or before **2:00 pm on Friday, January 11, 2019.**

The successful Contractor and its Subcontractors shall be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage rates at location of work.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be

required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage at the location of the work.

The work described in the contract is a public work subject to section 1771 of the California Labor Code.

No contractor or subcontractor, regardless of tier, may be listed on a Bid for, or engage in the performance of, any portion of this project, unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 and 1771.1. This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

The successful Bidder shall pay all persons providing services and/or any labor on site, including any University location, no less than the UC Fair Wage (defined as \$15 per hour as of 10/1/17) and shall comply with all applicable federal, state and local working condition requirements.
